- ➤ BYVC and its COVID Oversight Committee will continually monitor relevant COVID-related developments and will look to municipal/provincial/federal Governments and Health Authorities, as well as with provincial and national sporting organizations recommendations regarding modification, restriction, postponement and/or canceling of sporting and club activities.
- ➤ BYVC will make club members aware of any club schedule changes in as timely manner as possible arising from any restrictions or evolutions in COVID policies in the region.
- > BYVC will keep modifications and restrictions in place until advised that it is safe to resume activities by public health, government or sports organization officials, and only after a revised 'return to play' COVID Risk Assessment is undertaken by the club, verified by the COVID Oversight Committee, and approved by the Medical/Health Lead indicating that it is safe and appropriate to do so.
